Cynnigion i gyfarfod 17fed o Fedi 2020/ Motions for meeting 17th September 2020

Cllr Elwyn Williams:

1. **Cynnig** – Yn dilyn canslo'r gwasanaeth bws dros dro o Llangynnwr i Ysgol Uwchradd QE yn Johnstown, bydd yn rhaid i blant naill ai gerdded neu ddefnyddio tacsis, os nad oes gan rieni gludiant ar gael. Er mwyn cynorthwyo teuluoedd, bydd y Cyngor yn cynnig grant o £ 50 i'r teuluoedd yr effeithir arnynt, ffurflen i'w llunio gan y clerch a mater i bob teulu fydd gwneud cais.

Motion - Following the temporary cancellation of the bus service from Llangunnor to QE High School in Johnstown, children will either have to walk or use taxis, if parents do not have transportation available. To assist families the Council will offer a grant of £50 to the families affected, a form to be drawn up by the clerk and it will be for each family to make an application”.

1. **Cynnig** - Bydd Cyngor Cymuned Llangunnor, ar ôl gosod nifer o ddiffibrilwyr yn y gymuned yn ddiweddar, i ddangos ei ymrwymiad i iechyd a lles trigolion Llangunnor, pan fydd y rheolau pellhau cymdeithasol cyfredol yn caniatáu yn darparu hyfforddiant pellach ar sut i ddefnyddio diffibriliwr yn ddiogel.

Motion - Llangunnor Community Council having recently installed a number of defibrillators in the community will, to show its commitment to the health and well-being of residents of Llangunnor provide, when current social distancing regulations allow further training on how to safely use a defibrillator.

2. **Cynnig** - Mae ymarfer corff bob dydd yn rhywbeth a grybwyllwyd yn y cyfryngau dros y misoedd diwethaf, yn enwedig yn ystod camau cynnar y cloi, gyda llawer o drigolion lleol bellach yn mynd ar y strydoedd ac yn archwilio eu cymuned. Yn flaenorol, tynnwyd sylw Cyngor Cymuned Llangunnor fod ardaloedd yn y gymuned heb lwybr diogel i gerdded arno. Dylai Cyngor Cymuned Llangunnor ymchwilio gyda'r Awdurdod Lleol i ymarferoldeb a chostau darparu llwybrau ar hyd y ffyrdd hyn gyda golwg bosibl ar gynhyrchu cynllun gwella. I ddechrau dylem edrych ar yr ardaloedd canlynol - Ffordd Capel Dewi, Mount Pleasant / Heol Bolahaul a Heol Login.

Motion - Daily exercise is something that had been mentioned in the media over the last few months especially during the early stages of lockdown, with many local residents now taking to the streets and exploring their community. It has previously been brought to the attention of Llangunnor Community Council that there are areas within the community without a safe route to walk along. Llangunnor Community Council should investigate with the Local Authority the feasibility and costs of providing paths along these routes with a potential view of producing an improvement plan. Initially we should look at the following areas - Capel Dewi Road, Mount Pleasant/Heol Bolahaul and Heol Login.

3. **Cynnig** - Bydd Cyngor Cymuned Llangunnor gyda'i ymrwymiad i fod yn gyngor agored, tryloyw ac effeithiol yn rhoi modd ar waith i fonitro bod yr holl gynigion / eitemau a basiwyd mewn cyfarfodydd wedi cael eu gweithredu trwy aros ar agendâu / cofnodion cyfarfod nes bod camau wedi'u cymryd, ac ar yr adeg honno gellir cau a symud yr eitem. Bydd hyn yn caniatáu i bawb wybod bod penderfyniadau wedi'u gwneud yn effeithlon ac yn galluogi gofyn cwestiynau ynghylch ar unrhyw oedi.

Motion - Llangunnor Community Council with its commitment to be an open, transparent and effective council will put in place a means to monitor that all motions/items passed at meetings have been actioned by remaining on meeting agendas/minutes until action has been taken, at which time the item can be closed and removed. This will allow all to know that decisions have been carried out efficiently and enable questions to be asked regarding delays.

4. **Cynnig** - Dylai Cyngor Cymuned Llangunnor gymryd camau ychwanegol i wella ymddangosiad y gymuned. Dros y blynyddoedd mae'r cyngor wedi gweithio i wella ymddangosiad y gymuned a'r pyrth i'r gymuned trwy osod basgedi blodau a phlanwyr ym Mhensarn a Nantycaws a rhaglen o blannu cennin Pedr yn y gymuned.
- Plannwyr ar gyfer mynedfeydd Pibwrlwyd / Capel Dewi i Llangunnor (i'w drefnu ar gyfer y flwyddyn nesaf)
 - Nodi ardaloedd newydd a rampio plannu cennin Pedr yn y gymuned, fel Pibwrlwyd.
 - Cynnwys y gymuned ehangach ar gyfer plannu i helpu i ennyn teimlad o falchder yn y gymuned (yn ddarostyngedig i reoliadau pellhau cymdeithasol)

Motion - Llangunnor Community Council should take additional action to improve the appearance of the community. The council has over the years worked to improve the appearance of the community and the gateways to the community with the installation of flower baskets and planters at Pensarn and Nantycaws and a programme of daffodil planting within the community. The council can and should do more as below:

- Planters for Pibwrlwyd/Capel Dewi entrances to Llangunnor (to be arranged for next year)
- Identify new areas and ramp up daffodil planting within the community, such as Pibwrlwyd.
- Involvement of the wider community for planting to help instil a feeling of pride within the community (subject to social distancing regulations)

5. **Cynnig** - Dylai Cyngor Cymuned Llangunnor ymholi gyda'r Asiantaeth Cefnffyrdd a fyddent yn barod i lanhau / golchi pwysau o bryd i'w gilydd y ddau danffordd ar lwybr troed Sticle a Gwlyptir. Mae'r ddau lwybr hyn yn cysylltu Tregynwr / Penymorfa â thref Caerfyrddin ac yn cael eu defnyddio drwy'r amser, yn anffodus mae'r ddau danffordd wedi eu parddu ac yn llawn gwe pryf copyn, mae hyn yn lleihau effeithiolrwydd y goleuadau. A ellid gofyn iddynt hefyd a fyddent yn rhoi caniatâd i'r cyngor cymunedol greu murluniau wedi'u paentio o bosibl ar fynedfeydd y tanffyrdd hyn.

Motion - Llangunnor Community Council should enquire with the Trunk Road Agency whether they would be prepared to periodically clean/pressure wash the two underpasses on the Sticle and Wetland footpath. Both these routes link Tregynwr/Penymorfa with Carmarthen town and are very well-used, both underpasses have unfortunately over time become grimy and full of cobwebs which in turn reduce the effectiveness of the lighting. Could they also be asked whether they would give permission to the community council to potentially create painted murals on the entrances of these underpasses.
