#### Minutes of "remote" Events Committee (held Remotely on Thursday day 10<sup>th</sup> November 2022 at 7.30p.m.

Prior to dealing with the Agenda items Cllr Jenny Slate was unanimously elected as Chair for the ensuing year, as Cllr Bevan did not seek re-election. (Minute 11/22 EC)

Cllr Charlie Evans attended in addition to one elector present in addition to Howard Davies Clerk.

#### 3. Declaration of interest – None

**4.**The minutes of the meeting held on 29<sup>th</sup> September 2022 were unanimously approved (Minute 1122 – E4).

**5.** Following a brief discussion the following actions were agreed for the 2022 Llangunnor Lights "switch on"

I)Given these unpresented times of financial pressures and hardship it was felt prudent to delay the "switch on of the lights" until Wednesday 30<sup>th</sup> November to reduce energy costs.

ii)With Covid restrictions now eased it was unanimously agreed to return to the traditional format for the evening, with "Father Christmas" in attendance, along with pupils from Llangunnor School. The Minister of Babell Zion Newydd Chapel to be invited to offer prayers, with refreshments afterwards for those children attending, along with "Santa's Grotto" to be located at Babell Vestry.

III)Clerk to action the follow:

- a) To check if Babell Chapel and Vestry is available for the day and night of the 30<sup>th of</sup> November.
- b) To email all Councillors asking for volunteers to help on the day to with assembling "Santa's Grotto" and getting the venue ready.
- c) To email Nicola Walters PCSO to advise her of the "Switch on" and asking her, if possible, for a police presence at the Tywi Bridge Garage tree site.
- d) To Liaise with Aled Davies at the school to see if the date worked for them, and if they could supply amplifiers, etc.
- e) Speak to Roy Davies owner of the former Gailey Caravan site for his permission to use the tarmacadamed area on his property behind the fence adjacent to the tree.

6. Cllrs Jenny Slate, and Joan Evans volunteered to oversee the catering arrangements. Cllr Slate stated that she would approach local supermarkets, shops, and bakers to see if they would be prepared to support via donations of food, sweets, and selection boxes etc. Cllr Evans also agreed to approach the local W I to see if they can help with the serving of Tea's and Coffee's etc.

7.The Chair reminded everyone that the King's Coronation will take place on the 6<sup>th of</sup> May 2023 and suggested that consideration should be given to putting on another Community event at the park, building on the success of

this years Queen's Jubilee party, which had been well received by the residents of Llangunnor. An agenda item will be placed for our next meeting.
