1. To receive apologies for absence.

3. To approve the Minutes of previous meeting held on 25th July 2023 previously circulated.
4. To consider Llangunnor Playground Operational Inspection reports for the months May -September which have already been circulated electronically to all Councillors.
5. Update from Clerk on ongoing/scheduled park works.
6. To discuss safety concerns raised by a member of the public (email correspondence already circulated electronically) and the provision of safety railings. Two quotes received, one at £1500, and the other £1800 plus VAT.
7. To discuss three complaints received from our neighbouring residents at Maes Lewis Morris, regarding the branches of the Oak trees on our boundary extending into their gardens. Three of these Oak trees have Tree Preservations Orders registered on them. Paul Cleaver is scheduled to undertake our Annual Tree Inspection which will incorporate a survey of the bottom hedge around the large Oak trees near to the skateboard park to establish ownership and responsibilities, on Thursday 2nd November.
8. To discuss a quote received from Roman Solution for the supply of benches within the upper children's play area. Details have already been circulated to all Councillors. Costs 1.5M Beacon Bench £233.33, 2M £316.67 All plus VAT.
9. To discuss the provision of railings to the path to the memorial stone at an estimated cost of £2700-£4200 plus Vat. Quotes received and details circulated to all Councillors.
10. To approve a new Electricity Supplier from the quotes provided for the park.
11. To consider a request from St Clears Trots who are interested in organising a cross country championship race in March 2024 to be held at Llangunnor Park.
12. Update on controlled exit From Charlie's car. Email from Cllr Edward Thomas, Cabinet Minister Carms C C For Transport, Waste, and infrastructure Services which has been circulated electronically to all Councillors.
